UVOD

Prvi dodatek k drugemu zvezku rodovniške knjige za angleške polnokrvne konje, zrejene v Sloveniji vsebuje podatke o reji konj te pasme, od leta 1993, do vključno 2003. Reja angleških polnokrvnih konj temelji na maloštevilni populaciji plemenskih živali, ki so bile vse uvožene. Pričakujemo, da bo v prihodnjih letih večje število doma zrejenih živali vplivalo na povečanje števila plemenskih živali in s tem razcvet reje teh plemenitih konj v našem prostoru.

Rodovniška knjiga za angleške polnokrvne konje (Slovenian Stud Book – SSB) je bila ustanovljena na pobudo, še vedno maloštevilnih rejcev, leta 1993. Vse od ustanovitve rodovniške knjige je Republiška strokovna služba v konjereji (Slovenian Stud Book Authority – SSBA) vodila matično knjigovodstvo v skladu s standardi usklajenimi z International Stud Book Committee (ISBC).

SSBA bo tudi v prihodnje delovala v skladu z navodili, odločitvami in zahtevami ISBC, ter aktivno sodelovala v delu EMSBLC (European and Mediterranean Stud Book Liaison Committee).

Prepričani smo, da bo mednarodno priznavanje slovenske rodovniške knjige za angleške polnokrvne konje spodbudilo zanimanje za rejo polnokrvnih konj v Sloveniji in neposredno vplivalo na izboljšanje kvalitete pri nas zrejenih živali.

FOREWORD

This first supplement to volume two of the Slovenian Stud Book of Thoroughbred horses covers the years 1993 to 2003 inclusive. Thoroughbred breeding in Slovenia is founded on a relatively small population of imported breeding stock. In future we expect that home-bred fillies and colts will be registered for breeding in increasing numbers with a consequent effect on the strength and prosperity of Thoroughbred breeding in our country.

The Slovenian Stud Book Authority (SSBA) has since its inception (and this will continue) liaised closely with Thoroughbred breeders in Slovenia which has assisted in ensuring that the recording of breeding results has been undertaken to the International Stud Book Committee (ISBC) agreed standards.

The SSBA will implement all future instructions, decisions and requirements of the ISBC and be an active participant in meetings of the European and Mediterranean Stud Book Liaison Committee.

The granting of "approval" status will we trust stimulate further interest in breeding thoroughbreds in Slovenia with consequent improvement in the resident breeding stock.

PRAVILNIK O VODENJU RODOVNIŠKE KNJIGE ZA KONJE ANGLEŠKE POLNOKRVNE PASME SLOVENSKE REJE

1. UVOD

1.1. Za vodenje rodovniške knjige za konje angleške polnokrvne pasme (v nadaljnjem tekstu SSB - Slovenian Stud Book), je s strani Ministrstva za kmetijstvo, gozdarstvo in prehrano pooblaščen Republiška strokovna služba v konjereji (v nadaljnjem tekstu SSBA – Slovenian Stud Book Authority), ki samostojno vzdržuje vse potrebne registre - sezname in redno izdaja SSB.

1.2. SSB vsebuje:

- a. Indeks vseh konj, ki so vpisani v SSB.
- b. Seznam plemenskih kobil in naraščaja.
- c. Seznam plemenskih žrebcev.
- d. Seznam uvoženih plemenskih kobil in žrebcev
- e. Statistični pregled.

Nadaljnji izvodi SSB bodo dopoljnjeni s:

- f. Seznam izvoženih konj.
- g. Seznam imen konj, ki so bili v prejšnji izdaji SSB vpisani brez imena.
- h. Dodatki in popravki.

1.3. Seznam uvoženih konj, ki niso registrirani kot plemenske živali in ga vodi RSS ni sestavni del SSB.

1.4. Vse živali vpisane v SSB so, kot to zahteva ISBC (International Stud Book Committee), zavedene pod življenjsko številko, ki se uporablja v vseh evidencah v reji, športu in prometu.

1.5. Pri vodenju rodovnika SSBA upošteva vsa navodila in sklepe I.S.B.C. kot to predpisuje Mednarodni sporazum o reji in galopskih dirkah (International Agreement on Breeding and Racing) v členih 3.,4.,12.,13. in 14.

2. VPIS V SSB

V SSB so lahko vpisani konji angleške polnokrvne pasme:

- a. ki so potomci žrebca in kobile, ki sta bila sama ali vsi njuni predniki pred 1. januarjem 1980 vpisana v rodovno knjigo priznana s strani ISBC.
- b. za katere je mogoče zanesljivo dokazati osem zaporednih križanj (vključno s parjenjem, katerega rezultat so) s konji, ki izpolnjujejo pogoje iz točke a.
- c. ne glede na to, da konj izpolnjuje pogoje iz točke a. lahko SSBA zavrne vpis v SSB če ni mogoče zadovoljivo dokazati osem zaporednih križanj pod pogoji iz točke b. Zavrnitev vpisa je veljavna in dokončna, ko jo potrdi ISBC.

3. ISTOVETNOST KONJA – IDENTITETA

- 3.1. Preden sta katerikoli žrebec ali kobila vpisana v SSB kot plemenska žival, je potrebno ugotoviti - potrditi njegovo/njeno istovetnost.
- Lastnik živali mora vložiti vlogo za vpis žrebca ali kobile, v seznam plemenskih žrebcev ali kobil, v kateri so navedeni: ime živali, pod katerim je bila vpisana v rodovno knjigo, barva, starost, poreklo, lastnik in vsi znani podatki o dotedanji usodi živali.
 - SSBA preveri podatke o vseh dotedanjih lastnikih na osnovi Identifikacijskega dokumenta (ID) in po potrebi, uradnih potrdil o kupoprodaji.
 - SSBA preveri barvo in znamenja živali
 - Opravi se preiskava krvi živali na krvni tip. Vzorec krvi za preiskavo odvzame pooblaščen veterinar, preiskava pa se opravi v pooblaščenem laboratoriju. V primeru, da imajo plemenske kobile že opravljeno preiskavo na krvni tip, se pri njih ta opravi le ob pojavu suma v verodostojnost predložene dokumentacije.
- 3.2. V primeru, ko gre za uvoženo žival, rojeno v tujini, je potrebno predložiti Identifikacijski dokument (Passport). Izvozno potrdilo (Export certifikat) države, v kateri je bila žival rojena, pridobi SSBA od SBA države v kateri je bila žival rojena, oziroma države iz katere je bila uvožena. Podatki, zavedeni v Identifikacijski dokument (Passport) morajo biti istovetni podatkom, zavedenim v Izvozno potrdilo. Izvozno potrdilo SSBA trajno (oziroma do ponovnega izvoza živali) deponira.
- 3.3. Za plemenske živali, uvožene za čas, krajši od 9 mesecev, je potrebno predložiti Identifikacijski dokument (Passport).
- 3.4. Žival ne more biti registrirana kot plemenska po smrti, razen na osnovi presoje okoliščin s strani SSBA, a le v primeru, ko je bila pred smrtjo živali opravljena preiskava njene krvi na krvni tip na predpisan način.

4. LASTNIŠTVO

- 4.1. Za vsakega žrebca ali kobile, ki sta vpisana v seznam plemenskih živali je potrebno SSBA prijaviti vsako spremembo lastništva. Ta pogoj je potrebno izpolniti zaradi tekočega vodenja evidence, ni pa odločilno za nadaljnje postopke v zvezi z vpisom potomstva plemenske živali v SSB.
- 4.2. Za vpis žrebeta v ustrezen seznam se zahtevajo in uporabijo podatki o fizični ali pravni osebi, ki je bila v času žrebitve prijavljena pri SSBA kot lastnik kobile, torej podatki o rejcu. Podatki o lastništvu prijavljeni v SSBA in podatki o rejcu v Poročilu o žrebitvi (vloži za vpis žrebeta v SSB) morajo biti enaki.

5. VPIS - REGISTRACIJA ŽREBET

5.1. Redni postopek

5.1.1. Za vpis - registracijo potomstva plemenske kobile v ustrezen seznam SSB, mora rejec izpolniti naslednje pogoje:

- a. Predložiti SSBA uradno Potrdilo o pripustu z vpisanimi datumi prvega in zadnjega pripusta v pretekli plemenilni sezoni, vpisom njene življenjske številke in vpisano številko seznama pripuščenih kobil.
- b. Ob prvem pripustu je lastnik plemenjaka dolžan preveriti identiteto kobile. Za resničnost vseh navedb v Potrdilu o pripustu in preverjanje identitete ob prvem pripustu jamči lastnik plemenjaka s podpisom. Lastnik plemenjaka obenem tudi potrdi, da je bila kobilica oplojena po naravnem pripustu in ne osemenjena in da pri kobili ni bil opravljen prenos zarodka.
- c. Če je bila kobilica pripuščena pod dva ali več plemenjakov se predloži tudi potrdila o teh pripustih.
- d. Predložiti podpisano Poročilo o žrebitvi najkasneje v štirih tednih (28 dneh) po žrebitvi, v katerem so vpisani podatki o spolu, barvi, dnevu rojstva, državi rojstva. V primeru, ko gre za dvojčke, je to potrebno v dokumentu posebej označiti.
- e. Poročilo o žrebitvi je potrebno dostaviti tudi v primeru, če je kobilica ostala jalova, če je resorbirala ali zvrгла plod, če je bilo žrebe rojeno mrtvo, če je žrebe poginilo, ali pa, če je poginila kobilica - z označeno ustrežno rubriko tiskovine. Poročilo o žrebitvi se dostavi tudi v primeru, ko je bila kobilica pripuščena pod plemenjaka druge pasme. V primeru, da rejec poročila ne predloži, bo v SSB v rubriki o potomstvu kobile za tekoče leto vpis: brez povratne informacije (no return).
- f. Predložiti Potrdilo o istovetnosti žrebeta, v katerega vpiše podatke o starših, spolu, barvi, datumu rojstva in tri predloge za ime žrebeta rejec, pismeni opis žrebeta in oris znakov v diagram pa opravi s strani SSBA pooblaščen veterinar, ki to potrdi z navedbo dneva, podpisom in žigom.

TA OPIS MORA BITI OPRAVLJEN, PREDEN ŽREBE DOPOLNI ŠTIRI MESECE A ČIM BLIŽE TEMU TERMINU.

Opis živali mora vsebovati najmanj pet značilnih znamenj (od teh vsaj tri dlačne vrtince). Opis živali v potrdilu o istovetnosti mora biti opisen (vpis z velikimi tiskanimi črkami) in grafičen - oris.

- g. Na osnovi Potrdila o istovetnosti žrebeta izstavi SSBA Identifikacijski dokument (Passport)
- h. Zagotoviti dokazilo o poreklu na osnovi pregleda vzorca krvi žrebeta in če je to potrebno tudi očeta. Odvzem vzorcev krvi opravi pristojni veterinar, preiskava pa mora biti opravljena v pooblaščenem laboratoriju. Na osnovi teh vzorcev se preveri starševstvo žrebca in kobile in ugotovi krvni tip žrebeta. Vse rezultate preiskav dostavi pooblaščen laboratorij SSBA, ki dokumente arhivira. Dokumenti niso dostopni javnosti. V primeru - izvoz živali, jih na zahtevo SBA države uvoznice, SSBA posreduje le tej.
- i. Vplačati pristojbino za registracijo žrebeta.

5.1.2. Določila tega člena veljajo za žrebeta, ki se vpisujejo v SSB v letu rojstva..

5.2. Naknadni vpis žrebeta:

5.2.1. Za vpis žrebet, za katera postopek registracije ni bil opravljen v letu rojstva zaradi opustitve prijave žrebitve ali nepopolne dokumentacije, mora rejec izpolniti naslednje pogoje:

- a. Istovetnost žrebeta mora biti nedvomno potrjena z izjavo - poročilom vsaj dveh neodvisnih

strank (veterinar, s strani SSBA pooblaščen osebe)

b. Rejec mora vplačati pristojbino določeno za naknadni vpis žrebeta.

5.2.2. ŽIVALI, KI SO V TRENUTKU, KO JE BILA VLOŽENA ZAHTEVA ZA NAKNADNI VPIS, STARE ŠTIRI LETA ALI VEČ, NI MOGOČE VPISATI V SSB.

5.3. Nepopolni zahtevki za registracijo žrebeta

5.3.1. Nepopolne zahtevke za registracijo žrebeta SSBA zavrne in jih vrne rejcu v dopolnitev.

5.3.2. V takih primerih se za vpis žrebeta uveljavlja pristojbina, ki velja na dan vložitve dopoljenega zahtevka za registracijo.

5.3.3. Žrebeta, za katera rejec predloži dopolnjeno dokumentacijo, ni pa jim bil odvzet vzorec krvi za preiskavo na krvni tip, se registrirajo z dnem, ko je bila predložena dopolnjena dokumentacija, če se zagotovi odvzem krvnega vzorca v dveh mesecih od tega dne. Če slednji pogoj ni izpolnjen, se dokumentacija ponovno vrne rejcu v dopolnitev, registracija pa se opravi po določilih, prvih dveh odstavkov tega člena.

5.4. Izbira imena

5.4.1. Vpis imen opravi SSBA po postopku, ki ga predpisuje 14. Člen IABR.

5.4.2. SSBA hrani seznam zaščitenih imen.

5.4.3. Rejec ob vlogi zahtevka za registracijo v Potrdilu o istovetnosti žrebeta navede tri predloge imena, ki se začnejo z začetno črko imena matere, pravico do dokončno izbire imena pa ima RSS.

5.4.4. Potrditi ni mogoče:

- a. Imen, ki so na seznamu mednarodno zaščitenih imen,
- b. Imen, ki jih tvori več kot 18 mest, vključno z znaki in presledki
- c. Imen javnih osebnosti, brez izrecnega dovoljenja teh osebnosti ali njihovih družin,
- d. Imen, ki se končujejo s številkami,
- e. Imen, katerih del so inicialke ali znamenja,
- f. Imen, katerih pomen, izgovarjava ali črkovanje se lahko dojame kot vulgarno ali žaljivo,
- g. Če se črkujejo enako, ali če se izgovarjajo enako ali podobno kot zaščiteni imena ali imena konj, ki so manj kot deset (10) let starejši od konja, ki naj bi bil vpisan pod tem imenom,
- h. Če se pričnejo s črkovnim znakom.

5.4.4. Sprejeto ime je vpisano v konjev Identifikacijski dokument (Passport).

6. METODE RAZMNOŽEVANJA

6.1. Žrebe je lahko registrirano le:

- a. Če je produkt naravnega pripusta. Ta se lahko v istem ali naslednjih reprodukcijskih ciklikih pripuščene kobile večkrat ponovi.
- b. Če je rojeno po normalni dobi brestosti, kobili, ki je bila zabrejena na predpisan način.

6.2. Žrebet, ki so produkt osemenjevanja ali prenosa zarodka ni mogoče registrirati.

7. ZAVRNITEV REGISTRACIJE

Ne glede na popoln zahtevek za registracijo žrebeta in rezultate preiskave krvi na krvni tip, ki potrdijo navedene podatke o poreklu, se registracija žrebeta lahko zavrne, če barva žrebeta ni v skladu z barvo staršev, ali če navedena doba brejosti značilno odstopa od splošno uveljavljenih mejnih rokov.

8. IDENTIFIKACIJSKI DOKUMENT

- 8.1. Identifikacijski dokument se na predpisan način izda vsem konjem, vpisanim v SSB. Identifikacijski dokument je osnovni dokument za preverjanje istovetnosti živali. V Identifikacijskem dokumentu so označena in opisana značilna znamenja konja, vpisani podatki o rejcu, lastniku in konju, ter podatki o opravljenih zaščitnih cepljenjih in laboratorijskih preiskavah, kot to določajo predpisi SSBA.
- 8.2. Identifikacijski dokument ni potrdilo o poreklu in ne dokazuje lastništva.
- 8.3. Identifikacijski dokument je treba vrniti SSBA, če ta to zahteva.
- 8.4. V Identifikacijski dokument žrebcev in kobil, ki so vpisane v ustrezen register plemenskih živali, se ta registracija potrdi z uradnim zaznamkom, ki ga opravi SSBA v ustrezni rubriki dokumenta.
- 8.5. Kakršen koli vpis podatkov ali popravke lahko opravijo samo pooblašcene uradne osebe, ki to potrdijo s podpisom in žigom.
- 8.6. Registrirane plemenske kobile se lahko pripustijo šele, ko lastnik kobile predloži lastniku plemenjaka veljaven Identifikacijski dokument. Lastnik plemenjaka je pred pripustom dolžan preveriti identiteto kobile, za kar jamči s podpisom na Potrdilu o pripustu.
- 8.7. Ob spremembi lastništva se Identifikacijski dokument obvezno predloži SSBA, ki je edina pristojna za vpis novega lastnika.
- 8.8. SSBA ne upošteva zahtev za registracijo potomstva plemenskih kobil, dokler dejanski lastnik kobile ni na predpisan način vpisan v Identifikacijski dokument.
- 8.9. V primeru, ko konj, na katerega se Identifikacijski dokument nanaša, pridobi znamenja, mora lastnik obvestiti o tem SSBA, ki določi nadaljnji postopek za dopolnitev opisa konja.

9. EVIDENCA PRIPUSTOV

- 9.1. SSBA izstavi za vsakega priznanega plemenjaka lastniku le tega tiskovine:
 - a. Seznam pripuščenih kobil
 - b. Potrdil o pripustu
- 9.2. Lastnik plemenjaka je dolžan vpisati v seznam pripuščenih kobil vse pripuste vseh kobil z vsemi zahtevanimi podatki.
 - a. Če je kobila v isti plemenilni sezoni pripuščena pod dva ali več plemenjakov, mora biti to navedeno v rubriki "opombe", kobila mora biti vpisana v seznamu pripuščenih kobil vseh plemenjakov:
 - b. Po končanem pripustu je lastnik plemenjaka dolžan lastniku kobile vročiti pravilno izpolnjeno Potrdilo o pripustu. Če je kobila v isti plemenilni sezoni pripuščena pod dva ali več plemenjakov mora biti vpisana v seznamu pripuščenih kobil vseh plemenjakov, izdana morajo biti vsa pripadajoča Potrdila o pripustu.

- 9.3. Lastnik plemenjaka mora izstvaiti Potrdilo o pripustu za vsako kobilo, pripušeno pod njegovega žrebca.
- 9.4. Po končani plemenilni sezoni mora lastnik plemenjaka najkasneje do 30.septembra v tekoem letu dostaviti pravilno izpolnjen Seznam pripušenih kobil in izpolnjene kopije Potrdil o pripustu, kot tudi preostala – neizstavljena Potrdila o pripustu.
- 9.5. Če lastnik plemenjaka ne upošteva določil tega pravilnika o vodenju evidence pripustov in ostalih obveznostih, njegov žrebec (žrebci) v naslednji plemenilni sezoni ne more biti več priznan kot plemenjak.

10. IZVOZ

Preden je konj izvožen, mora biti njegov Identifikacijski dokument dostavljen SSBA, ki vpiše in potrdi izvoz. Če naj bi bil konj izvožen za stalno, (več kot en mesec in eno potovanje v primeru tekmovalnih konj oz. več kot devet mesecev v primeru plemenskih živali), izstavi SSBA na zahtevo SBA države uvoznice Izvozno potrdilo s preverjenim potrdilom o istovetnosti.

11. PREISKAVE KRVI NA KRVNI TIP

- 11.1. Preiskave na krvni tip lahko opravi le pooblašeni laboratorij, ki poročilo o opravljeni preiskavi in rezultate le te dostavi SSBA.
- 11.2. Rezultati, ki jih opravi nepooblaščen laboratorij, se priznajo le v primeru:
 - a. ko je žival za katero se zahteva krvni tip poginil(a), preden ji je bilo v normalnih okoliščinah mogoče odvzeti vzorce krvi za preiskave, ko gre za ugotavljanje krvnega tipa uvoženega žrebca ali kobile,
 - b. ko gre za plemenjaka, v primeru, ko je v SSB registrirana plemenska kobila pripušena v tujini .

12. PUBLIKACIJE

Rodovna knjiga za angleške polnokrvne konje slovenske reje se izdaja vsaka štiri leta, z vsakoletnimi dopolnili.

RULES AND REQUIREMENTS OF THE SLOVENIAN STUD BOOK

1. GENERAL PROVISIONS

- 1.1. The Slovenski (Slovenian) Stud Book (SSB) is the record of thoroughbred breeding in Slovenia. The Slovenian Stud Book Authority (SSB) which is established under the control of Ministry of Agriculture, Forestry and Nutrition and therefore independent from breeders has responsibility for the SSB, its rules and ensuring its regular publication.
- 1.2. The SSB consists of:
 - a. Index of all horses contained in the SSB.
 - b. List of Broodmares.
 - c. List of Stallions
 - e. List of imported Broodmares and Stallions
 - f. Statistical overview.and in future Volumes:
 - d. List of exported horses.
 - g. List of names for those horses which were unnamed in the last volume of the SSB.
 - h. Appendices and corrections
- 1.3. A list of imported horses which are not used as breeding stock is also maintained by the SSBA but is not included within the SSB.
- 1.4. All animals entered in the SSB have a life number in accordance with International Stud Book Committee (ISBC) requirements.
 - a. The SSBA accepts and implements all instructions and decisions of the ISBC needs to all instructions and decrees of the ISBC and complies with the International Agreement on Breeding and Racing Articles 3, 4, 12, 13 and 14.

2. CONDITIONS OF ENTRY TO THE SSB

To be eligible to be registered in the SSB the following qualifications must be met:

- a. The horse must be the product of a mating between a sire and a dam both of which are registered prior to 1st January 1980 in a Stud Book Approved by the ISBC or must trace in all lines of its pedigree to horses so registered,
or
- b. The horse must be able to prove satisfactorily eight recorded crosses consecutively with horses in the category described in a. above, including the cross of which it is the progeny.
- c. Notwithstanding that a horse may qualify under a. above, the SSBA may have the right to refuse to record it in the SSB if the horse can not prove satisfactorily eight recorded crosses (including the cross of which it is the progeny) with horses described in the category a. and b. above, but such refusal shall not be effective unless it is confirmed by the unanimous decision of the ISBC.

2. IDENTITY

- 3.1. Before any Stallion or Mare can be registered in the SSB as breeding stock the animal's identity must be established by
 - a. the completion by the animal's owner of the appropriate Stallion or Broodmare Registration Form, recording the animal's registered name, colour, age, pedigree, present owner, and previous history so far as known.
 - b. the SSBA tracing the animal through all its ownerships in particular by reference to its Passport and by obtaining certificates of sale where necessary.
 - c. the provision of current markings of the animal, taken by an SSBA official.
 - d. by establishing the blood type of the animal. In respect of all animals, this will require the provision of a current blood sample taken by a certified veterinarian, the analysis being done in a certified laboratory. The only exception to this will apply to Broodmares whose blood type has previously been officially established, unless for reasons of doubt a current blood sample from the Broodmare is considered necessary.
- 3.2. In the case of imported animals which were themselves foaled abroad an Export Certificate or Passport (for horses imported for less than nine months) must be received from the Stud Book Authority (SBA) of the animal's country of birth. The SSBA holds the export certificate until such time as the Broodmare or Stallion is re-exported.
- 3.3. A current identity certificate is required for checking against the export certificate.
- 3.4. No animal may be registered as breeding stock retrospectively, after it has died, except at the discretion of the SSBA and only if the animal's blood type has been officially established prior to the animal's death.

4. OWNERSHIP

- 4.1. For every Stallion or Mare registered as breeding stock the change of ownership must be lodged with the SSBA. This requirement is necessary for the purpose of the administration, and it does not influence the registration procedure of offspring from registered animals.
- 4.2. For the purpose of registration the breeder of the dropped foal is the person or entity registered as such with the SSBA at the time of foaling. The stated breeder must be the same on the Foal Registration Form as lodged with the SSBA.

5. REGISTRATION OF FOALS

5.1. Current Returns

- 5.1.1. For the produce of a Mare to be registered in the SSB the following must be received from the breeder:
 - a. An official Certificate of Covering with all dates of covering in the previous breeding season, her life number and the number of the List of covered Mares.
 - b. Before the first covering the Stallion Owner must check the Mare's identity and with his signature guarantee that all data in the Certificate of Covering is correct and that the Mare was served naturally and that artificial insemination was not used.

- c. If the Broodmare was covered by two or more Stallions these certificates must also be received.
- d. An official Foaling Report, signed by the Breeder no later than four weeks (28 days) after the foaling, giving the required details of the produce, namely the colour, sex, date of birth and country of foaling. Twins must be indicated.
- e. In the event of no live produce the official Foaling Report must still be completed indicating whether the Broodmare was Barren, Aborted Early or Slipped, or that the produce was born dead or has died or the Broodmare has died. In the case of breeding to a Stallion of another breed the Foaling Report must also be returned. Failure to report this information will result in the term “No Return” appearing on the Broodmare’s produce line for that year in the SSB.
- f. A Foal Identification Certificate stating the parentage, colour, sex, date of birth of the produce and three name suggestions for the foal, prepared by the Breeder, and showing a written and graphic description of the markings of the produce, prepared signed and dated by the SSBA official.

MARKINGS SHOULD BE TAKEN BEFORE THE FOAL IS FOUR MONTHS OLD AND AS NEAR TO THIS DEADLINE AS POSSIBLE.

A minimum number of identifying features (normally five, usually to include three hair whorls) is required. Identity certificates should incorporate both narrative (completed in block capitals) and graphic descriptions.

- g. The SSBA issues an Identification Document on the basis of the Foal Identification Certificate.
- h. Blood samples from the Foal, and where necessary, the Broodmare and Stallion, each taken by a certified veterinarian, the analysis being done in a certified laboratory, to confirm that the Mare and Stallion qualify as the parents of the Foal by blood typing. The certified laboratory sends all the results of the blood typing to the SSBA, which archives the data. The data is not public, except when a horse is exported and on a demand from the SBA of the importing country the SSBA will forward the data.
- i. Payment of the foal registration fee.

5.1.2. The above requirements apply to produce which are registered in their year of foaling.

5.2. Late Returns

5.2.1. For produce whose registration is not sought or completed until after the year of foaling, in addition to the above requirements for current returns, the following will apply:

- a. The Foal Identification Certificate must be supported by at least two (a veterinarian surgeon and a SSBA certified person) independent statements to establish the identity of the produce beyond all doubt.
- b. The fee at the then current rate for late foal registration must be paid.

5.2.2. NO APPLICATION TO REGISTER PRODUCE CAN BE CONSIDERED FOR PRODUCE WHICH ARE AGED FOUR YEARS OR OVER AT THE TIME OF APPLICATION.

5.3. Incomplete Returns

5.3.1. Returns which are incorrect or incomplete, or which lack any of the required supporting documentation, cannot be accepted and will be returned to the Breeder for completion.

5.3.2. The rate of fee payable for registration of produce will be the rate in force on the date when the completed return is received.

5.3.3. Produce for which a completed return has been made in all respects except the provision of required blood samples will be accepted at the fee applicable on the date the return is received, provided that the necessary blood samples are received within two months from that date. If the required blood samples are not provided within two months, the return will not be accepted and will be returned to the Breeder for completion, and will only be accepted under the provisions of the first two paragraphs of these conditions.

5.4. Naming

5.4.1. The SSBA registers names fully in accordance with Article 14 of the IABR.

5.4.2. The SSBA keeps a list of protected names.

5.4.3. A Breeder is required to provide three suggestions for names on the Foal Identification Certificate with the same first letter of its dam's name. The SSBA has the final decision in determining whether a name is acceptable for registration.

5.4.4. Names cannot be accepted if they are already registered subject to the conditions on re-use of names (Art.14.of the IABR) and if:

- a. they appear on the International List of Protected Names,
- b. they have more than eighteen characters, including signs or spaces,
- c. they are the name of a public person, without that person's or their family's permission,
- d. they are followed by numbers,
- e. they are made up of initials or figures,
- f. their meaning , pronunciation or spelling may be thought obscene or insulting,
- g. in spelling they are identical to and in pronunciation, identical or similar to a protected name or a name registered for a horse whose year of foaling is within ten years of that of the horse in question,
- h. they start with any other sign than a letter.

5.4.5. The registered name is recorded in the horse's passport.

6. METHODS OF REPRODUCTION

6.1. A Foal is not eligible to be registered unless

- a. it is a product of a natural service or covering which is the physical mounting of a Broodmare by Stallion. This natural service may include the immediate reinforcement of the Stallion's service or cover by a portion of the ejaculate produced by the Stallion during that service or cover of that same Broodmare;
- b. a natural gestation took place in and delivery was from the body of the Mare in which the foal was conceived.

No Foal which was conceived by artificial insemination or which was the subject of an embryo transplant can be registered.

7. REFUSAL OF REGISTRATION

Notwithstanding that a complete return may be made for a Foal, and that the Foal may qualify by blood typing as being the progeny of its stated parents, the application to register the Foal may be refused either if its reported coat colour is inconsistent with the registered coat colours of its stated parents, or if the reported gestation period of its dam is significantly at variance with generally accepted limits.

8. IDENTIFICATION DOCUMENT - PASSPORT

- 8.1. A Passport is issued in respect of each horse registered in the SSB. The Passport is the basic identifying document of the animal for which it is issued. This document shows descriptive particulars registered in respect of the animal, details of Breeder, Owner, vaccination and laboratory analysis record, prescribed by the SSBA.
- 8.2. The Passport is not a Certificate of Origin and cannot be used to prove ownership.
- 8.3. The Passport must be returned to the SSBA on demand.
- 8.4. The SSBA officially endorses the appropriate section of a Stallion's or Broodmare's Passport to confirm that they are registered as breeding stock.
- 8.5. All entries and changes to Passport can be only made by official persons who must confirm the amendment with a signature and rubber stamp.
- 8.6. Registered Broodmares can only be covered after the Broodmare's owner shows the Broodmare's Passport to the Stallion's owner. The Stallion's owner must check the Broodmare's identity which he confirms with his signature on the Certificate of Covering.
- 8.7. Whenever a Broodmare or Stallion changes hands the Passport must be returned to the SSBA for endorsement with details of new owner.
- 8.8. The SSBA will not accept a return for registration of produce until the actual owner is correctly recorded in the Passport.
- 8.9. The SSBA should be advised if a horse has acquired markings.

9. RECORDING OF COVERINGS

- 9.1. The SSBA issues to every registered Stallions owners the following forms:
 - a. List of covered Broodmares
 - b. Covering Certificates
- 9.2. Stallion Owners are required to enter
 - a. the List of covered Broodmares with the details of every Broodmare covered with all demanded information. If the Mare is covered by more than one Stallion, this must also be indicated;
 - b. the Covering Certificate with the details of the covered Broodmare with all required information and declarations. In particular, if a Broodmare is covered by more than one Stallion, a separate entry must be made for each Stallion.
- 9.3. Stallion Owners must issue a Covering Certificate to the Owner of each Mare covered by their Stallion.
- 9.4. Stallion Owners must return the completed List of covered Broodmares, completed counterfoils

and remaining Covering Certificates by the 30th September.

- 9.5. If a Stallion Owner does not follow this instructions in particular if he does not return the List of covered Broodmares and the completed counterfoils to the SSBA the Stallion cannot be registered for the next season.

10. EXPORTS

The SSBA requires the receipt of a horse's passport prior to export to endorse and if the horse is to be exported permanently i.e. more than one month and one trip (racing animal) or nine months (breeding animal) an application for issue of an export certificate along with a current identity certificate of the horse is required.

11. BLOOD TYPING

11.1. Only an officially designated laboratory can carry out blood typing for the SSBA

11.2. Exceptions are accepted only in the following cases:

- a. Only if the animal concerned has died before a valid blood sample could reasonably have been taken from it, to establish the blood type of an imported Broodmare or Stallion.
- b. In the case of Stallions only, for the purpose of parentage testing a Foal conceived abroad.

12. PUBLICATIONS

The SSB published in full every four years with supplements annually.

UVOD

Republiška strokovna služba v konjereji (Slovenian Stud Book Authority – SSBA) je v času od svoje ustanovitve rodovne knjige za angleške polnokrvne konje (Slovenian Stud Book – SSB) v letu 1993, registrirala tudi posamezne živali, vpisane v NTB register (non-thoroughbred register). V NTB register so vpisane živali iz posameznih rodovnih knjig oz. posamezne živali, ki ne izpolnjujejo pogojev za vpis v rodovno knjigo angleških polnokrvnih konj (SSB), zaradi njihove nedokazane polnokrvnosti. Registracija teh živali poteka po identičnem postopku kot registracija angleških polnokrvnih konj, vpisanih v SSB.

V slovenski NTB register so lahko vpisani konji angleške polnokrvne pasme:

- a. ki so vpisani v NTB register druge s strani ISBC priznane rodovne knjige.
- b. ki so potomci žrebcev in kobil, vpisanih v slovenski NTB register.
- c. živali, ki so bile registrirane in vpisane v Yugo Stud book, ki s strani ISBC ni priznana rodovna knjiga.

FOREWOD

The Slovenian Stud Book Authority - SSBA has since creating the Slovenian Stud book of Thoroughbred horses - SSB in the year 1993 registered also some NTB horses (non-thoroughbred horses). NTB register (non-thoroughbred register) includes animals which are recorded in separate Stud Books or animals, that not suit all the conditions for the Stud Book of Thoroughbred horses, because of their not proved full – bloodedness. Registration of these animals is the same as for Thoroughbred horses, included in SSB.

The Slovenian NTB register can include thoroughbred horses that:

- a. are registered in other from ISBC recognized Stud Book.
- b. the produce of stallions and mares included in Slovenian NTB register.
- c. horses registered and enlisted into Yugo Stud book, which is not from ISBC recognized Stud Book.
