PRAVILNIK O VODENJU RODOVNIŠKE KNJIGE ZA KONJE ANGLEŠKE POLNOKRVNE PASME SLOVENSKE REJE

1. UVOD

1.1 Za vodenje rodovniške knjige za konje angleške polnokrvne pasme (v nadalnjem tekstu SSB - Slovenian Stud Book), je s strani Ministrstva za kmetijstvo in okolje pooblaščena PRO VF (v nadalnjem tekstu SSBA – Slovenian Stud Book Authority), ki samostojno in neodvisno od rejcev vodi rodovniško knjigo, zagotavlja izvajanje predpisanih pravil in redno izdaja SSB kot strokovno publikacijo.

1.2. SSB vsebuje:

- a) Indeks vseh konj, ki so vpisani v SSB
- b) Seznam plemenskih kobil in naraščaja
- c) Seznam plemenjakov in jihovih potomcev
- d) Seznam plemenskih žrebcev
- e) Statistični pregled
- f) Seznam uvoženih moških in ženskih živali
- g) Seznam izvoženih moških in ženskih
- h) Seznam poginulih živali
- i) Seznam imen konj, ki so bili v prejšnji izdaji SSB vpisani brez imena
- j) Dodatki in popravki

1.3. Vse živali vpisane v SSB so, kot to zahteva ISBC (International Stud Book Committee), zavedene pod življenjsko številko, ki se uporablja v vseh evidencah v rejci, športu in prometu.

1.4. Pri vodenju rodovniške knjige SSBA upošteva vsa navodila in sklepe ISBC kot to predpisuje Mednarodni sporazum o rejci in galopskih dirkah IABRW (International Agreement on Breeding and Racing) v členih 3, 4, 12, 13, 14 in 15.

1.5. Angleški polnokrvni konj je konj, ki je registriran v rodovniški knjigi za angleške polnokrvne konje v državi, kjer je rojen, le ta pa je bila v času njegove registracije priznana s strani ISBC.

2. VPIS V SSB

2.1. V SSB so lahko vpisani konji angleške polnokrvne pasme če so izpolnjeni sledeči pogoji:

- a) potomec mora biti proizvod parjenja žrebeca in kobile, ki sta vpisana v katerokoli rodovniško knjigo priznano s strani ISBC,
- b) od katerih je bil eden ali oba starša prevedena v rodovniško knjigo iz katerenkoli registra ne-pолнокрвних конј - NTB pod pogoji, določenimi v členu 13.4.1. IABRW.

2.2. Angleški polnokrvni konj je produkt naravnega pripusta – fizičnega zaskoka kobile s penetracijo penisa in ejakulacijo semena v rodila kobile. V času takšnega pripusta se lahko kot pomoč del žrebčevega ejakulata takoj vstavi direktno v rodila kobile, ki se pripušča.

2.3. Naravna brejost mora ves čas – od oplodive pa vse do žrebitve potekati v obrejeni kobili, ki mora žrebe ožrebiti. Žrebeta, ki so produkt osemenjevanja, prenosa jajčnih celic ali zarodkov, kloniranja ali kakršnihkoli drugih posegov v dednino ni mogoče registrirati.

2.4. V primeru kakršnegakoli posega v dednino bodočega ali že registriranega angleškega polnokrvnega konja vse od časa njegovega spočetja, tekom brejosti ali kadarkoli v obdobju njegovega življenja pomeni, da le ta izgubi status konja angleške polnokrvne pasme.

3. ISTOVETNOST KONJA - IDENTITETA

3.1. Preden sta katerikoli žrebec ali kobila vpisana v SSB kot plemenska žival, je potrebno ugotoviti - potrditi njegovo/njeno istovetnost na sledeči način:

- a) Lastnik živali mora vložiti vlogo za vpis, v kateri so navedeni sledeči podatki:

ime živali, življenska številka, številka elektronskega odzivnika, barva, datum rojstva, spol, poreklo, država rojstva, rejec, lastnik in vsi znani podatki o dotedanjih spremembah lastništva živali.

b) Vsi podatki o spremembah lastništva bo SSB preveril in potrdil na osnovi Identifikacijskega dokumenta – Passport (v nadalnjem besedilu ID) in kupoprodajnih pogodb.

c) SSBA preveri barvo in znamenja živali.

d) Opravi se molekularna genetska preiskava lastnega vzorca krvi ali žime (v nadalnjem besedilu - preiskava na DNK tip). Vzorec krvi ali žime za preiskavo odvzame pooblaščena oseba, preiskava pa se opravi v pooblaščenem ISAG laboratoriju. V primeru, da imajo plemenske kobile že opravljeno preiskavo na DNK tip, se pri njih ta opravi le ob pojavi suma v verodostojnost predložene dokumentacije.

3.2. V primeru, ko gre za uvoženo žival, je potrebno SSBA predložiti Identifikacijski dokument. SBA države, iz katere žival prihaja mora SSBA neposredno posredovati Izvozno potrdilo (Export certifikat) in poročilo z rezultati opravljene preiskave na DNK tip ali krvne skupine. Izvozno potrdilo SSBA trajno (ozioroma do ponovnega izvoza živali) deponira. Podatki, zavedeni v ID, ki sprembla žival morajo biti istovetni podatkom, zavedenim na Izvoznem potrdilu.

3.3. Za plemenske živali, pripeljane v Slovenijo za čas, krajši od 9 mesecev, je potrebno predložiti ID. SBA države, iz katere žival prihaja mora SSBA neposredno posredovati potrjen obrazec Prijava rejskega premika - Breeding Clearance Notification (BCN) ter poročilo z rezultati opravljene preiskave na DNK tip ali krvne skupine. Podatki, zavedeni v ID, ki sprembla žival morajo biti istovetni podatkom, zavedenim na Prijavi rejskega premika.

3.4. Žival ne more biti registrirana kot plemenska po smrti, razen na osnovi presoje okoliščin s strani SSBA, a le v primeru, ko je bila pred smrtno živali opravljena preiskava njene krvi ali žime na DNK tip po predpisanim načinu.

4. LASTNIŠTVO

4.1. Za vsakega žrebcu ali kobilo, ki sta vpisana v seznam plemenskih živali je potrebno SSBA prijaviti vsako spremembo lastništva na predpisanim obrazcu, podpisanim s strani prodajalca in kupca. Sprememba lastništva mora biti vpisana v ID.

4.2. Ta pogoj je potrebno izpolniti zaradi tekočega vodenja evidenc, ni pa odločilno za nadaljnje postopke v zvezi z vpisom potomstva plemenske živali v SSB.

4.3. Za vpis žrebeta v ustrezni seznam se zahtevajo in uporabijo podatki o fizični ali pravni osebi, ki je bila v času žrebitve prijavljena pri SSBA kot lastnik kobile, torej podatki o rejcu. Podatki o lastništvu prijavljeni v SSBA in podatki o rejcu v Poročilu o žrebitvi (vlogi za vpis žrebeta v SSB) morajo biti enaki.

5. VPIS - REGISTRACIJA ŽREBET

5.1. Redni postopek

5.1.1 Za vpis - registracijo potomstva plemenske kobile v ustrezni seznam SSB, mora rejec izpolniti naslednje pogoje:

a) Predložiti SSBA uradno Potrdilo o pripustu z vpisanim:

- imenom in življensko številko plemenjaka,
- imenom in življensko številko kobile,
- datumi prvega in zadnjega pripusta v pretekli plemenilni sezoni,
- vpisano številko seznama pripuščenih kobil,
- izjavo, ki jo podpiše lastnik ali njegov pooblaščenec, da so podatki, vpisani v Potrdilo o pripustu resnični, da je bila kobia zabrejena v naravnem pripstu in da žrebe ni produkt umetne osemenitve, prenosa jajčne celice ali zarodka, kloniranja ali kakršnihkoli drugih posegov v dednino.

b) Ob prvem pripstu je lastnik plemenjaka dolžan preveriti identiteto kobile. Za resničnost vseh navedb v Potrdilu o pripstu in preverjanje identitete ob prvem pripstu jamči lastnik plemenjaka s podpisom. Lastnik plemenjaka obenem tudi potrdi, da je bila kobia oplojena po naravnem pripstu in da žrebe ni produkt umetne osemenitve, prenosa jajčne celice ali zarodka, kloniranja ali kakršnihkoli drugih posegov v dednino.

c) Če je bila kobia pripuščena pod dva ali več plemenjakov se predloži tudi potrdila o teh pripustih.

d) Predložiti podpisano Poročilo o žrebitvi najkasneje v štirih tednih (28 dneh) po žrebitvi, v katerem so vpisani:

- ime in življenska številka očeta,
- ime in življenska številka matere,
- natančen datum rojstva,
- podatki o spolu,

- podatki o barvi,
- podatki o rejcu,
- država rojstva ter
- izjavo lastnika kobile ali njegovega pooblaščenca, ki potrjuje da je bila kobila oplojena po naravnem pripustu in da žrebe ni produkt umetne osemenitve, prenosa jajčne celice ali zarodka, kloniranja ali kakršnihkoli drugih posegov v dednino.

e) V primeru, ko gre za dvojčke, je to potrebno v dokumentu posebej označiti.

f) Poročilo o žrebitvi je potrebno dostaviti tudi v primeru, če je kobila ostala jalova, če je resorbirala ali zvrgla plod, če je bilo žrebe rojeno mrtvo, če je žrebe poginilo, ali pa, če je poginila kobila - z označeno ustrezno rubriko tiskovine. Poročilo o žrebitvi se dostavi tudi v primeru, ko je bila kobila pripuščena pod plemenjaka druge pasme. V primeru, da rejec poročila ne predloži, bo v SSB v rubriki o potomstvu kobile za tekoče leto vpis: brez povratne informacije (no return).

g) Popis žrebeta opravi s strani SSBA pristojen preglednik na predpisanim obrazcu – Zapisnik o pregledu žrebeta, na katerem so vpisani:

- ime in življenska številka očeta,
- ime in življenska številka matere,
- natančen datum rojstva,
- podatki o barvi,
- podatki o spolu,
- predlogi rejca za ime žrebeta,
- podatki o rejcu,
- država rojstva,
- številka mikročipa
- vrsta odvzetega vzorca.

Preglednik opis potrdi z navedbo dneva, podpisom in žigom. Opis živali mora vsebovati najmanj pet značilnih znamenj (od teh vsaj tri dlačne vrtince). Opis živali v Potrdilu o istovetnosti mora biti opisan (vpis z velikimi tiskanimi črkami) in grafičen - oris.

TA OPIS MORA BITI OPRAVLJEN PRED ODSTAVITVIJO IN PREDEN ŽREBE DOPOLNI ŠEST MESECEV OZ. ČIM BLIŽE TEMU TERMINU.

h) Preverjanje porekla se opravi na osnovi pregleda vzorca krvi ali žime žrebeta in če je to potrebno tudi matere in očeta. Odvzem vzorcev krvi ali žime opravi strani SSBA pristojen preglednik, preiskava pa mora biti opravljena v pooblaščenem ISAG laboratoriju. Na osnovi teh vzorcev se preveri DNK tip žrebeta ter starševstvo žrebcia in kobile. Pooblaščen laboratorij dostavi rezultate preiskav SSBA, ki dokumente arhivira. Dokumenti niso dostopni javnosti. V primeru izvoza živali, jih SSBA skupaj z Izvoznim potrdilom posreduje SBA države uvoznice.

i) Za žrebeta rojena v letu 2006 in kasneje je obvezna označitev z implantacijo elektronskega odzivnika, ki se vstavi v sredino vratnega gребena z leve strani. Označitev opravi pooblaščeni preglednik ob identifikacijskem pregledu živali.

j) Na osnovi Zapisnika o pregledu žrebeta izstavi SSBA ID, v katerem se potrdi preverjanje starševstva in z nalepkjo s črtno kodo označitev z elektronskim odzivnikom.

k) Rejec je dolžan plačati predpisano pristojbino za registracijo žrebeta.

l) Določila tega člena veljajo za žrebeta, ki se vpisujejo v SSB v letu rojstva.

5.2. Naknadni vpis žrebeta

5.2.1. Za vpis žrebet, za katera postopek registracije ni bil opravljen v letu rojstva zaradi opustitve prijave žrebitve ali nepopolne dokumentacije, mora rejec izpolniti še naslednje pogoje:

a) Istovetnost žrebeta mora biti nedvomno potrjena z izjavo - poročilom vsaj dveh neodvisnih strank (veterinar in s strani SSBA pooblaščena oseba)

b) Rejec mora vplačati pristojbino določeno za naknadni vpis žrebeta.

5.2.2. **ŽIVALI, KI SO V TRENUTKU, KO JE BILA VLOŽENA ZAHTEVA ZA NAKNADNI VPIS, STARE ŠTIRI LETA ALI VEČ, NI MOGOČE VPISATI V SSB.**

5.3. Nepopolni zahtevki za registracijo žrebeta

5.3.1. Nepopolne zahtevke za registracijo žrebeta SSBA zavrne in jih vrne rejcu v dopolnitiv.

5.3.2. V takih primerih se za vpis žrebeta uveljavlja pristojbina, ki velja na dan vložitve dopolnjenega zahtevka za registracijo.

5.4. Izbira imena

5.4.1. Vpis imen opravi SSBA po postopku, ki ga predpisuje 14. člen IABR.

5.4.2. SSBA hrani seznam zaščitenih imen v skladu s 14. členom IABR

5.4.3. Rejec ob vlogi zahtevka za registracijo žrebeta navede tri predloge imena , ki se začnejo z začetno črko imena matere, pravico do dokončno izbire imena pa ima RSS.

5.4.4. Potrditi ni mogoče:

- a) Imen, ki so na seznamu mednarodno zaščitenih imen, v skladu s 14. členom IABR.
- b) Imen, ki jih tvori več kot 18 mest, vključno z znaki in presledki.
- c) Imen javnih osebnosti, brez izrecnega dovoljenja teh osebnosti ali njihovih družin.
- d) Imen, ki se končujejo s številkami.
- e) Imen, katerih del so inicialke ali znamenja, presledki ali kakršnakoli ločila.
- f) Imen, katerih pomen, izgovarjava ali črkovanje se lahko dojame kot vulgarno ali žaljivo za posamezni ali etnične, politične ali verske skupnosti.
- g) Če se črkujejo ali izgovarjajo enako ali podobno kot zaščitena imena ali imena konj, ki so manj kot deset let starejši od konja, ki naj bi bil vpisan pod tem imenom.
- h) Če se ne pričnejo s črkovnim znakom.
- i) Če je eden izmed ožjih sorodstvenih članov že registriran s tem imenom.

5.4.5. Sprejeto ime je vpisano v konjev ID.

6. ZAVRNITEV REGISTRACIJE

- a) Vsa dokumentacija za registracijo žrebeta mora biti potrjena z rezultatom o preverjanju starševstva z analizo DNA tipa. V primeru, da rezultati analize DNA starševstva ne potrdijo, se registracija žrebeta zavrne.
- b) Ne glede na popoln zahtevek za registracijo žrebeta in rezultate preiskave krv ali žime na DNK tip, ki potrdijo navedene podatke o poreklu, se registracija žrebeta lahko zavrne, če barva žrebeta ni v skladu z barvo staršev, ali če navedena doba brejosti značilno odstopa od splošno uveljavljenih mejnih rokov.

7. IDENTIFIKACIJSKI DOKUMENT - PASPORT

7.1. Identifikacijski dokument se na predpisani način izda vsem konjem, vpisanim v SSBA. Identifikacijski dokument je osnovni dokument za preverjanje istovetnosti živali. V skladu z mednarodnimi pravili so v ID-ju navedi vsaj naslednji podatki:

- naslov izdajatelja in SSBA
- ime konja
- življenska številka (UELN)
- datum rojstva
- spol
- država rojstva
- rejec
- lastnik
- izdaja Rodovniške knjige, v kateri je konj vpisan
- poreklo konja (4 generacije)
- označena in opisana značilna znamenja konja
- potrjeno preverjanje starševstva s predpisanimi preiskavami na DNK tip
- dodatna označitev z elektronskim odzivnikom z nalepko s črtno kodo
- podatki o opravljenih zaščitnih cepljenjih in laboratorijskih preiskavah, preiskavah na prepovedane farmakološke pripravke in zdravljenjih.

7.2. Identifikacijski dokument potrujuje izvor in poreklo živali, ni pa izkaz o lastništvu. Vpisi v ID se sicer načelno obravnavajo kot resnični vendar njihove verodostojnosti in točnosti v oddelkih, v katere jih ne vnašajo s strani SBA pooblaščene osebe ni mogoče garantirati.

7.3. Identifikacijski dokument je treba vrniti izdajatelju - SSBA, kadarkoli ta to zahteva. V primeru pogina oz. izločitve živali, je ID potreben vrniti SSBA, ki ga arhivira.

7.4. V Identifikacijski dokument žrebcev in kobil, ki so vpisane v ustrezni register plemenskih živali, se ta registracija potrdi z uradnim zaznamkom, ki ga opravi SSBA v ustrezni rubriki dokumenta.

7.5. Kakršen koli vpis podatkov ali popravke lahko opravijo samo pooblaščene uradne osebe, ki to potrdijo s podpisom in žigom.

7.6. Registrirane plemenske kobile se lahko pripustijo šele, ko lastnik kobile predloži lastniku plemenjaka veljaven ID. Lastnik plemenjaka je pred pripustom dolžan preveriti identiteto kobile, za kar jamči s podpisom na Potrdilu o pripstu.

7.7. Ob spremembi lastništva se ID obvezno predloži SSBA, ki je edina pristojna za vpis novega lastnika.

7.8. SSBA ne upošteva zahtev za registracijo potomstva plemenih kobil, dokler dejanski lastnik kobile ni na predpisani način vpisan v ID.

7.9. V primeru, ko konj, na katerega se ID nanaša, pridobi znamenja, mora lastnik obvestiti o tem SSBA, ki določi nadaljnji postopek za dopolnitev opisa konja.

8. EVIDENCA PRIPUSTOV

8.1. SSBA izstavi za vsakega priznanega plemenjaka lastniku le tega tiskovine:

- a) Seznam pripuščenih kobil
- b) Potrdila o pripravi

8.2. Lastnik plemenjaka je dolžan vpisati v seznam pripuščenih kobil vse pripravite vseh kobil z vsemi zahtevanimi podatki.

a) Če je kobia v isti plemenilni sezoni pripuščena pod dva ali več plemenjakov, mora biti to navedeno v rubriki "opombe", kobia mora biti vpisana v seznamu pripuščenih kobil vseh plemenjakov.

b) Po končanem pripravi je lastnik plemenjaka dolžan lastniku kobile vročiti pravilno izpolnjeno Potrdilo o pripravi. Če je kobia v isti plemenilni sezoni pripuščena pod dva ali več plemenjakov mora biti vpisana v seznamu pripuščenih kobil vseh plemenjakov, izdana morajo biti vsa pripadajoča Potrdila o pripravi.

8.3. Lastnik plemenjaka mora izstaviti Potrdilo o pripravi za vsako kobile, pripuščeno pod njegovega žrebcem.

8.4. Plemenilna sezona se prične ne prej kot 15. februarja in traja vse do 15. Avgusta v tekočem letu. Registracija žrebet, ki so potomci kobil, pripuščenih pred navedenim datumom se lahko zavrne.

8.5. Po končani plemenilni sezoni mora lastnik plemenjaka najkasneje do 30. novembra v tekočem letu dostaviti pravilno izpolnjen Seznam pripuščenih kobil in izpolnjene kopije Potrdil o pripravi, kot tudi preostala – neizstavljeni Potrdili o pripravi.

8.6. Če lastnik plemenjaka ne upošteva določil tega pravilnika o vodenju evidence pripravov in ostalih obveznosti, njegov žrebec (žrebci) v naslednji plemenilni sezoni ne more biti več priznan kot plemenjak.

9. IZVOZ

Preden je konj izvožen, mora biti njegov ID dostavljen SSBA, ki na osnovi namena in trajanja izvoza izstavi potreben dokument.

a) Če je konj izvožen za stalno, SSBA izstavi SBA države uvoznice Izvozno potrdilo s preverjenim potrdilom o istovetnosti in poročilom z rezultati opravljene preiskave na DNK tip ali krvne skupine. V primeru da SBA države uvoznice ni uradno priznana, se izstavi le kopija Izvoznega potrdila, original pa se zadrži.

b) V primeru začasnega izvoza z namenom pipusta (90 dni) SSBA izstavi SBA države uvoznice obrazec Prijava rejskega premika v skladu s 3. členom IABRW in poročilo z rezultati opravljene preiskave na DNK tip ali krvne skupine.

10. MOLEKULARNO GENETSKE PREISKAVE

SSBA zagotavlja, da imajo vsi angleški polnokrvni konji dodatno preverjeno in potrjeno poreklo na osnovi krvnega tipa ali molekularnih genetskih preiskav krvi, dlake ali drugih bioloških vzorcev. Ob enem potrjuje da:

10.1. Molekularno genetske preiskave za preverjanje porekla opravlja le laboratorij, ki ga SSBA v ta namen pooblašči.

10.2. Izbran laboratorij mora biti član ISAG in mora sodelovati na primerjalnem testiranju, da zadovolji standardom ISBC.

10.3. Pooblaščen laboratorij dostavi rezultate preiskav SSBA, ki dokumente arhivira. Dokumenti niso dostopni javnosti.

10.4. V primeru izvoza živali, jih SSBA skupaj z Izvoznim potrdilom posreduje SBA države uvoznice, ki je uradno priznana s strani ISBC.

11. PUBLIKACIJE

Vsako leto se k rodovniški knjigi za angleške polnokrvne konje slovenske reje izda dopolnitev v obliki priloge. Pravila o vodenju rodovniške knjige veljajo za konje registrirane do 31.12.2016.

RULES AND REQUIREMENTS OF THE SLOVENIAN STUD BOOK OF THOROUGHBRED HORSES

1. GENERAL PROVISIONS

1.1. The Slovenian Stud Book (SSB) is the record of thoroughbred breeding in Slovenia. The Slovenian Stud Book Authority (SSBA) which is established under the control of Ministry of Agriculture and the Environment and therefore independent from breeders has responsibility for the SSB, its rules and ensuring its regular publication.

1.2. The SSB consists of:

- a) Index of all horses contained in the SSB
- b) List of Broodmares and their produce
- c) List of Stallions and their produce
- d) List of Stallions
- e) Statistical overview
- f) List of imported male and female horses
- g) List of exported male and female horses
- h) Obituary of horses
- i) List of names for those horses which were unnamed in the previous volume of the SSB
- j) Appendices and corrections

1.3. All animals entered in the SSB have a life number in accordance with International Stud Book Committee (ISBC) requirements.

1.4. The SSBA accepts and implements all instructions and decisions of the ISBC needs to all instructions and decrees of the ISBC as prescribed by International Agreement on Breeding and Racing Articles IABRW 3, 4, 12, 13,14 and 15.

1.5. A thoroughbred is a horse which is recorded in the Thoroughbred Stud Book of the country of its foaling, that Stud Book having been granted Approved status by the ISBC at the time of its official recording.

2. CONDITIONS OF ENTRY TO THE SSB

2.1. To be eligible to be registered in the SSB all the following requirements must be satisfied:

- a) the horse must be the product of a mating between a sire and a dam, both of which are recorded in an approved Thoroughbred Stud Book, or
- b) either or both must have been promoted from a Non-Thoroughbred (NTB) register under the terms set out in Article 13. paragraph 4.1. of IABRW.

2.2. The thoroughbred must be the result of a stallion's mating with a mare which is the physical mounting of a mare by a stallion with intromission of the penis and ejaculation of semen into the reproductive tract. As an aid to the mating and if authorized by the Stud Book Authority – SBA of a country certifying the thoroughbred, a portion of the ejaculate produced by the stallion during such mating may immediately be placed in the reproductive tract of the mare being bred.

2.3. A natural gestation must take place in, and delivery must be from, the body of the same mare in which the foal was conceived. Any foal resulting from or produced by the processes of artificial insemination, embryo transfer or transplant, cloning or any other form of genetic manipulation not herein specified, shall not be eligible for recording in SSBA.

2.4. Modification of the heritable genome of a prospective or registered Thoroughbred, during its conception, gestation or at any stage thereafter in its existence, will result in that horse forfeiting its status as a Thoroughbred.

3. IDENTITY

3.1. Before any stallion or mare can be registered in the SSB as breeding stock the animal's identity must be established by:

- a) The animal's owner must submit the entry Form with the follow information:
registered name, life number, microchip number, colour, date of birth, sex, pedigree, country of birth, breeder, present owner, and all known previous history of ownership changes.
- b) All information about previous owners will be checked and confirmed by SSBA according to the Passport and valid documents of sale.

- c) The SSBA checks the horse's colour and description.
- d) Establishing the DNA type of the animal. In respect of all animals, this will require the provision of a current blood or hair sample taken by a SBA official, the analysis being done in a certified ISAG laboratory. The only exception to this will apply to broodmares whose DNA type has previously been officially established, unless for reasons of doubt a current blood or hair sample from the broodmare is considered necessary.

3.2. In the case of imported animals it is necessary to submit the Passport. The SBA of exporting country must send the Export certificate and DNA profile or blood type directly to the SSBA which permanently retain the Export Certificate until next re-exportation. Information listed in the Passport must correspond with the information listed on the Export Certificate.

3.3. For imported breeding horses visiting Slovenia for less than nine months the requirement for the provision of an Export Certificate may be replaced by the Breeding Clearance Notification (BCN) issued by the SBA of exportation. The SBA of exporting country must send the Export certificate and DNA profile or blood type directly to the SSBA. Information listed in the Passport must correspond with the information listed on the BCN.

3.4. No animal may be registered as breeding stock retrospectively, after it has died, except at the discretion of the SSBA and only if the animal's DNA type has been officially established prior to the animal's death.

4. OWNERSHIP

4.1 For every stallion or mare registered as breeding stock, all changes of ownership must be reported to the SSBA with the official Change of ownership form signed by both old and new owner of the animal. The change of ownership is registered in animal's Passport in which SSBA endorses the new owner.

4.2. This request must be satisfied for the purpose of accurate and up-to-date record keeping and does not influence to the registration procedure of offspring from registered animals in the SSBA.

4.3 For the purpose of the registration of the foal, the breeder is the person or entity registered with the SSBA as owner of the mare at the time of foaling. The stated breeder must be the same on the Foal registration form as lodged with the SSBA.

5. REGISTRATION OF FOALS

5.1. Current Returns

5.1.1. For the produce of a mare to be registered in the SSB the following must be received from the breeder:

- a) An official Certificate of covering with:
 - name and life number of the stallion,
 - name and life number of the mare,
 - the first and last dates of covering in the previous breeding season,
 - the number of the List of covered mares,
 - the statement signed by the stallion owner or his authorised agent that all data in the Certificate of covering is correct and that the mare was served naturally and that artificial insemination, embryo transfer or transplant, cloning or any other form of genetic manipulation not herein specified, was not used.
- b) Before the first covering, the stallion owner must check the mare's identity and with his signature guarantee that all data in the Covering certificate is correct and that the mare was served naturally and that artificial insemination, embryo transfer or transplant, cloning or any other form of genetic manipulation not herein specified, was not used.
- c) If the broodmare was covered by two or more stallions these certificates must also be received.
- d) An official Foaling report, signed by the breeder no later than four weeks (28 days) after the foaling, giving the required details of the produce:
 - name and life number of the stallion,
 - name and life number of the mare,
 - exact date of foaling,
 - colour of the foal,
 - gender of the foal,
 - name of the breeder of the foal,
 - country of foaling,
 - the statement signed by the mare owner or his authorised agent that the foal was not result of artificial insemination, embryo transfer or transplant, cloning or any other form of genetic manipulation not herein specified.
- e) Twins must be indicated.

f) In the event of no live produce the official Foaling report must still be completed indicating whether the broodmare was barren, aborted early or slipped, or that the produce was born dead or has died or the broodmare has died. In the case of breeding to a stallion of another breed the Foaling report must also be returned. Failure to report this information will result in the term "No return" appearing on the broodmare's produce line for that year in the SSB.

g) The description of the foal must be recorded by a person authorised by SSBA on an official form provided by the SSBA certifying the Thoroughbred which should include:

- name and life number of the stallion,
- name and life number of the mare,
- exact date of foaling,
- colour of the foal,
- gender of the foal,
- suggestions for the foal name,
- name of the breeder of the foal,
- country of foaling
- microchip number
- type of taken sample.

A detailed description both narrative (completed in block capitals) and graphic of permanent and acquired markings of the foal which should include all leg markings, face markings, hair whorls, scars, tattoos, brands and microchip number, if found, which should be substantiated by physical inspection. A minimum number of identifying features (normally five, usually to include three hair whorls) is required.

MARKINGS SHOULD BE TAKEN BEFORE THE FOAL IS SIX MONTHS OLD AND AS NEAR TO THIS DEADLINE AS POSSIBLE WHILST STILL UNDER THEIR DAM.

h) Blood or hair samples from the foal, and where necessary, the broodmare and stallion, each taken by SBA official at the time of recording the description, the analysis being done in a certified ISAG laboratory, to confirm that the mare and stallion qualify as the parents of the foal by DNA typing. The certified laboratory sends all the results of the DNA typing to the SSBA, which archives the data. The data is not public, except when a horse is exported the SSBA will forward the data with the export certificate.

i) For produce foaled in 2006 and in subsequent years, implantation with a microchip as an aid to its identification is obligatory. Implantation with a microchip is performed by the SSBA official at the time of recording the description, in the area of the nuchal ligament, mid crest, on the foal's left side.

j) Confirmation of DNA and implantation with a microchip is provided by the animals Passport being signed and dated by SBA official. The microchip number bar code label must be affixed by SBA official to the animals Passport.

k) Payment of the foal registration fee.

l) The above requirements apply to produce which are registered in the year of foaling.

5.2. Late Returns

5.3.1. For produce whose registration is not sought or completed until after the year of foaling, in addition to the above requirements for current returns, the following will apply:

a) The description record of the foal must be supported by at least two (a veterinarian surgeon and a SSBA certified person) independent statements to establish the identity of the produce beyond all doubt.

b) The fee at the current rate for late foal registration must be paid.

5.3.2. NO APPLICATION TO REGISTER PRODUCE CAN BE CONSIDERED FOR PRODUCE WHICH ARE AGED FOUR YEARS OR OVER AT THE TIME OF APPLICATION.

5.3 Incomplete Returns

5.3.1. Returns which are incorrect or incomplete, or which lack any of the required supporting documentation, can not be accepted and will be returned to the breeder for completion.

5.3.2 The rate of fee payable for registration of produce will be the rate in force on the date when the completed return is received.

5.4. Naming

5.4.1. The SSBA registers names fully in accordance with Article 14. of the IABR.

5.4.2. The SSBA keeps a list of protected names in accordance with Article 14. of the IABR.

5.4.3. A breeder is required to provide three suggestions for names on the Foal identification certificate with the same first letter of its dam's name. The SSBA has the final decision in determining whether a name is acceptable for registration.

5.4.4. Names cannot be accepted if either they are already registered subject to the conditions on re-use of names (Art.14. paragraph III of the IABR) or if:

- a) they appear on the International List of Protected Names,
- b) they have more than eighteen characters, including signs or spaces,

- c) they are the name of a public person, without that person's or their family's permission,
 - d) they are followed by numbers,
 - e) they are made up entirely of or include initials, figures, hypensis, full stops, commas, signs, exclamation marks, inverted commas, forward or back slash, colon and semi-colon,
 - f) they are suggestive or have a vulgar meaning, obscene or insulting meaning; names considered in poor taste or names that may be offensive to religious, political or ethnic groups,
 - g) pronunciation or spelling may be thought obscene or insulting, in spelling they are identical to and in pronunciation, identical or similar to a protected name or a name registered for a horse whose year of foaling is within ten years of that of the horse in question,
 - h) they start with another sign than a letter
 - i) they are already registered to a sibling or parent of the horse in question.
- 5.4.5. The registered name is recorded in the horse's passport.

6. REFUSAL OF REGISTRATION

- a) The submitted documentation for foal registration has to be verified by DNA parentage testing. If the DNA analysis does not confirm the submitted documentation for foal registration, the registration will be rejected.
- b) Notwithstanding that a complete return may be made for a foal, and that the foal may qualify by DNA typing as being the progeny of its stated parents, the application to register the foal may be refused either if its reported coat colour is inconsistent with the registered coat colours of its stated parents, or if the reported gestation period of its dam is significantly at variance with generally accepted limits.

7. IDENTIFICATION DOCUMENT - PASSPORT

7.1. A Passport is issued in respect of each horse registered at birth in the SSB. The Passport is the basic identifying document of the animal. In accordance with international requirements the Passport contain at least the following information:

- name and address of SSBA
- name of the horse
- life number (UELN)
- date of birth
- sex
- country of birth
- breeder
- owner
- the respective volume of the Stud book in which the entry appears
- pedigree (four generations)
- outline diagram and written description
- indication that the horse has been DNA typed and parentage tested
- details of implantation with a microchip - microchip number bar code label
- data for medical treatment and medication control.

7.2. The Passport is also a Certificate of origin but cannot be used to prove ownership. While the information contained is believed to be correct, its accuracy cannot be guaranteed, in particular where this is dependent on information supplied.

7.3. The Passport is the property of the SSBA and must be returned to the SSBA on demand. After the death of the horse, Passport has to be returned to the SSBA, where it will be archived.

7.4. The SSBA officially endorses the appropriate section of a stallion's or broodmare's Passport to confirm that they are registered as breeding stock.

7.5. All entries and changes to Passport can be only made by official persons who must confirm the amendment with a signature and rubber stamp.

7.6. Registered broodmares can only be covered after the broodmare's owner shows the broodmare's Passport to the stallion's owner. The stallion's owner must check the broodmare's identity which he confirms with his signature on the Certificate of covering.

7.7. Whenever a broodmare or stallion changes hands the Passport must be returned to the SSBA for endorsement with details of new owner.

7.8. The SSBA will not accept a return for registration of produce until the actual owner is correctly recorded in the Passport.

7.9. The SSBA should be advised if a horse has acquired markings.

8. RECORDING OF COVERINGS

8.1. The SSBA issues to every registered stallions owner the following forms for each stallion:

- a) List of covered broodmares
- b) Covering certificates

8.2. Stallion owners are required to enter:

a) The List of covered broodmares with the details of every broodmare covered with all demanded information. If the mare is covered by more than one stallion, this must also be indicated.

b) The Covering certificate with the details of the covered broodmare with all required information and declarations. In particular, if a broodmare is covered by more than one stallion, a separate entry must be made for each stallion.

8.3. Stallion owners must issue a Covering certificate to the owner of each mare covered by their stallion.

8.4. The breeding season start not before 15.th February and continue till 15.th August each year. The registration of foal born as an offspring of broodmare covered before this date can SSBA refuse.

8.5. Stallion owners must return to SSBA the completed List of covered broodmares, completed counterfoils and remaining Covering certificates by the 30th November.

8.6. If a stallion owner does not follow these instructions in particular if he does not return the List of covered broodmares and the completed counterfoils to the SSBA the stallion can not be registered for the next covering season.

9. EXPORTS

The Passport of the horse must be submitted to the SSBA prior to export for registration of exportation.

a) If the horse is exported permanently the SSBA issue or transmits directly to the relevant foreign SBA an Export certificate with details of horse's identity and DNA profile or blood type of the horse. If the foreign SBA is not approved, only a copy will be issued, while the original Certificate is kept.

b) If the horse is exported temporary (for coverings-90 days), SSBA will issue to the relevant foreign SBA the Breeding Clearance Notification (BCN) according to Article 3 of IABRW and DNA profile or blood type of the horse.

10. DNA TYPING

The SSBA certify the Thoroughbred requires further evidence of parentage testing based upon typing of genetic factors present in blood, hair and/or other biological samples and must certify:

10.1. The genetic typing is only undertaken by a laboratory approved by SSBA for that purpose.

10.2. The laboratory is an institutional member of ISAG and participates to the satisfaction of the ISBC in comparison tests.

10.3 The certified laboratory sends all the results of the DNA typing to the SSBA, which archives the data. The data are not public.

10.4. All genetic typing results and details are maintained in strict confidence and are only disclosed to other SBA granted approved status by the ISBC.

11. PUBLICATION

The SSB published annually the supplement to last volume of Stud book. The Rules and requirements of the Slovenian Stud book apply for the thoroughbred horses registered until 31.12.2016.
